



# WASTEC Awards Program 2011

The WASTEC Awards provide a unique opportunity to recognize the best in our industry. Help us honor our most valuable asset: our members.

We made it easier to nominate someone for a WASTEC Employee of the Year Award. Simply complete the nomination form and return it no later than January 13, 2012. We'll confirm receipt and schedule an appointment to interview you about the nominated employee's attributes and contributions to make our determination. We'll provide you with some guidelines about what we'll cover in the interview, so we can learn about all the wonderful qualities the nominee possesses.

## Eligibility

The award recipient must be an employee of a WASTEC member company, and the company must be a member in good standing, at the time of the nomination as well as when the awards are presented. Past winners may not receive the same award in two consecutive years.

## Nominations

One nominee per category, per company. To submit a nomination, simply complete the short nomination form and return to WASTEC.

## Judging

The Employees of the Year will be selected by a panel of judges representing manufacturers and other member types. A phone interview will be conducted with the nominator to gather information about the nominee's achievements and contributions to the company.

The Member of the Year and Distinguished Service award winners will be selected by the WASTEC Board of Governors.

## Recognition of Winners

Winners will be notified by mail/email in February 2012 and announced at the WASTEC Annual Conference in March 2012. Awards will be presented at WasteExpo 2012; should your employee be chosen as a winner, it is understood that he/she will travel to Las Vegas at your company's expense, to accept the award.

## 2011 WASTEC Employee of the Year Nomination

### Nomination Category:

**Engineering:** This award is designed to recognize excellence of an engineering employee at a WASTEC member company. The candidate does not have to be a degreed engineer but must be involved in the design of the product or in a manufacturing/industrial engineering position. The employee will be judged on contributions to the company in the areas of design, evaluation, and manufacturing.

**Production:** This award is designed to recognize excellence of a front line worker involved in the actual manufacturing/assembling of equipment. The employee will be judged on contributions to the company in the areas of quality, productivity, service, and cost reduction.

**Sales/Marketing:** This award is designed to recognize excellence of a sales and/or marketing employee of a WASTEC member company. The candidate should be at the representative level and will be judged on specific successes and how these benefited the company in the areas of sales, marketing, customer service and product knowledge.
